Our intrepid leader, Ray Day, N6HE did his usual great job in getting and keeping things organized, and those who attended will attest to the fun had by all. I won't take the wind from Ray's sails by revealing some of the more interesting, and occasionally outrageous, details about the trip he'll be presenting the highlights at our meeting this month. I will tell you, however, that we made 1247 contacts between Wednesday evening and Sunday morning, working all 50 states and contacting 32 DX entities. If you've never been on a DXpedition, or had the thrill of being on the "short end" of a pileup of stations wanting to work YOU, you might want to consider joining next year's IOTA team. Okay, okay, I know that the accommodations on the island are, shall we say, a bit, er, rustic, but that's part of the adventure. And, who knows? Back in 2010 we were there for the tsunami. You never can tell what Murphy will throw at you!

Coming up on 14 May is this year's Palos Verdes Marathon, an event for which the PVARC has provided critical communication support for many years. A change in the course this year has created a number logistical issues, but one fact is clear: we'll need a minimum of 22 hams to cover the race at the start/finish line, at aid stations, at the several parking areas, and in course "rover" vehicles. If you've got a VHF/UHF handheld transceiver, we need YOU for this event, and it's not too soon to contact Diana, Al6DF to volunteer for duty!

The next big event on the calendar after the PV Marathon is Field Day, June 25-26. Over the past two years, I've stepped back from the role of event chairman that I accepted for many years. I felt that new blood was needed to rejuvenate the club's participation in this, the biggest domestic amateur radio operating event of the year. And...yes... people stepped up and got involved and, not incidentally, had a great time doing it. So, if you didn't participate last year, you should definitely do so this year.

PVARC's Radio Help Requested for 2011 Palos Verdes Marathon on May 14; Members with HT Radios Needed at Locations in PVE, RHE, and RPV



When our club handles radio communications for the 45th annual Palos Verdes Marathon on May 14th there will be a new course for runners and a new set of major logistical challenges for the Marathon organizers.

The PVARC is meeting with the Marathon organizers and Marathon medical team on March 14th (after this QRO issue's deadline) to learn where our radio operators are required, but we already expect to need more operators than in recent years.

If you have an HT radio, we need your help. This year we also expect to have some short-duration shifts and relief operator positions available.

One of the biggest challenges for this year's Marathon was where to park 2,500 cars in Rancho Palos Verdes. Eleven parking locations have now been secured (see map, right) and four shuttle buses will take runners to and from the Start/Finish line outside the Terranea Resort.



We'll be providing more information about our Marathon radio operating positions during the March 16th monthly meeting at Hesse Park and also post it on our club website.

We hope you can be a PVARC radio operator on May 14th. The PV Marathon is a great opportunity for field operation while serving our communities. ■

ARRL Requests Hams Write Their Members of Congress about H.R. 607; Bill Proposes Taking Away 430-440 MHz From Amateur Radio's 70cm Band

On February 10, 2011, Rep. Peter King (R-NY), Chairman of the House Homeland Security Committee, introduced H.R. 607, the "Broadband for First Responders Act of 2011," which has been referred to the House Energy and Commerce Committee (which handles telecommunications legislation). The bill addresses certain spectrum management issues including the creation and maintenance of a nationwide Public Safety broadband network.

As part of that network, the Bill provides for the allocation of the so-called "D-Block" of spectrum in the 700 MHz range for Public Safety use. HR 607 uniquely, provides for the reallocation of other spectrum for auction to commercial users, in order to offset the loss of revenue that would occur as the result of the allocation of the D-Block to Public Safety instead of commercial auction. H.R. 607 lists, among the bands to be reallocated for commercial auction within ten years of the passage of the Bill, the paired bands 420-440 MHz and 450-470 MHz.

The inclusion of most of the Amateur 70-cm spectrum as one of the replacement bands is a major problem. The 420-440 MHz band is not Public Safety spectrum and should not be included in any spectrum swap of Public Safety allocations.

While the ARRL and all Amateurs support the work of Public Safety and recognize their need for dedicated spectrum which would promote interoperability, the ARRL vigorously opposes HR 607 in its present form. HR 607 is a direct threat to our limited spectrum and the ARRL encourages all amateurs to appropriately voice their opposition to this bill.
